The Subject Leader of Food Technology will be expected to:

**Teaching and learning**

1. Plan and teach a full timetable.
2. Create and establish a climate which enables students to develop and maintain a positive attitude and confidence.
3. Plan and deliver high quality lessons, which meet the needs of all students, including the most able, those with SEND and those in receipt of pupil premium, in line with the department's schemes of learning.
4. Work with the Curriculum Leader to set appropriate targets for all students, using a range of data (including ASP ,SISRA, Reading ages, CATs, etc) and monitor progress towards these, with appropriate and timely intervention when necessary.
5. As Subject Leader, contribute towards faculty and whole-school self-evaluation, including development planning.
6. Ensure there is development of students' literacy, numeracy and ICT skills through the subject.
7. Ensure that homework is set in accordance with school and department policy.
8. Ensure that work is frequently marked so that students can learn from formative feedback and that students respond to this.
9. Provide appropriate extra-curricular activities to motivate and engage students.
10. Implement and monitor agreed school policies, appropriate practices for assessing, recording and reporting student achievement.
11. Maintain effective behaviour management through the implementation of any departmental and whole school agreed procedures including the Positive Attitude to Learning Policy.

12. Contribute towards appropriate meetings at whole school and departmental levels.
13. Ensure that Health and Safety issues are followed effectively and consistently.
14. Promote whole school Social, Moral, Spiritual and Cultural Education throughout the school, including contributing to assemblies.
15. Take an appropriate part in the school's appraisal process.
16. Share good practice within the department and across the school.
